Merging PDF Files Into One By Using Acrobat Software: The acrobat reader will start processing, and within few minutes, you will have your file. However, you may have to adjust the number of files you have to merge finally, as in some versions of Acrobat, you may have the limited files only option.

How to Combine PDF files in Adobe Reader

If you don't see the Adobe PDF Reader add-on, try the other options on the menu. For example, on some systems, the add-on appears when you select Run Without Permission. Click the Enable button.
